Change of Director's Interest Notice

2. The Appendix 3Y has been lodged late due to an administrative oversight at the time that Mr Chan was allocated DRP shares. The Appendix 3Y has been lodged promptly after the oversight was identified.
3. The company confirms it has the following arrangements in place to order to achieve compliance with Listing Rules 3.19A and 3.19B:
 - a) AusNet Services has a written agreement in place with each Director, requiring the Director to notify the company of any changes in their relevant interests within three business days of the change
 - b) AusNet Services has in place Guidelines for Dealing in Securities which specify the circumstances under which Directors are permitted to deal in shares of AusNet Services
 - c) any breaches of disclosure requirements are reviewed by the Disclosure Committee and the Board.
4. All Directors will be reminded of their obligations to notify the company of any changes in their relevant interests.
5. The company is satisfied that it has in place the necessary reporting procedures for compliance with Listing Rules 3.19A and 3.19B and that this was an isolated incident. Nevertheless, the company will immediately adopt additional procedures in respect of the company's distribution plans.
